If the subscriber company does not provide the information (including maps and descriptions) within that time frame, the subscriber customer will be billed at a rate of \$125/hr.

## **Monthly Training Topics:**

Training will be web-based, lecture style training conducted by Safety Dragons. A single topic will be offered at three separate times during the month to allow for all necessary personnel to participate. Quizzes and Training Record forms will be sent to the subscriber company's designated manager. It is solely the responsibility of the subscriber company to ensure quizzes are completed by the trainees and the training records are thoroughly completed and accurate, in accordance with OSHA regulations.
